Introduction

We are a global non-profit based in Kansas City, Missouri working to ensure safe water and sanitation for all. We go beyond traditional approaches to safe water and sanitation, focusing on addressing the underlying causes of this global crisis and innovating to deliver large-scale and sustainable change. Summary

We seek a highly motivated, adaptive, and creative International Portfolio Manager to provide strategic, technical, and operational oversight of and support to existing programs and engagements with in-country partners, execute initiatives funded by major donors, assist in exploring new geographies and channels as needed, develop ongoing pipeline of new projects, and participate in evaluation, learning, and capacity development activities. This full-time position will be based in Kansas City, MO (headquarters) or San Francisco, CA (satellite office), with regular travel to Latin America. The International Portfolio Manager will report to the Senior Regional Manager, Latin America and work closely with the regional staff in countries with Water.org programs. He/she will also work with other members of the Water.org International Programs team and other US-based teams. The person in this position **must be fluent in Spanish and Portuguese.**

Key Responsibilities

Manage and monitor Water.org programs and engagements implemented with local partner organizations (financial institutions and water/sanitation service providers)- Estimated time: 25%

- Oversee implementation of programs/engagements, including delivery of funding and technical assistance. Manage relationships with partners in collaboration with country office staff.
- Develop and manage contracts with and provide support to consultants hired to supplement Water.org's programmatic work
- Ensure optimal operational and financial performance of on-going programs through a combination of in-country support, monitoring, and technical assistance to address implementation challenges
- Maintain databases and track partners' WaterCredit loan performance and financial expenditure on a regular basis
- In collaboration with international staff, ensure execution of in-country program monitoring visits of partner organizations.

Execute and manage agreements with institutional donors- Estimated time: 30%

- Assist in research and proposal writing to institutional donors, and support foundation requests
- Facilitate execution of overall initiative and program/engagement-specific deliverables
- Oversee initiative revenues expenditures, and budgets in collaboration with Finance team
- Write technical, financial, and narrative progress reports
- Respond to requests and serve as program knowledge base externally for donors and internally for the Development team
- Assist in the organization of donor visits to countries, working closely with international staff to develop visit itineraries and arrange logistics.

Support development of new programs and initiatives- Estimated time: 20%

- Assist in identification and certification of new partner organizations, including financial and non-financial institutions
- Solicit and evaluate new program proposals from partner organizations
- Support the design and launch new programs in conjunction with regional office staff and local partners, including designing program goals, budgets, activities, and deliverables
- Contribute to development of new partnership models and innovative approaches to building partner capacity.

Assist in exploring new geographies and types of partnerships as needed- Estimated time: 15%

- Support geographic and channel-specific market assessments executed in conjunction with third parties
- Provide input into development of new strategies and approaches for new geographies and channels in partnership with other International Programs team members.

Participate in evaluation, learning, and capacity development activities- Estimated time: 5%

- Facilitate evaluation-related activities of programs/engagements in conjunction with the International Programs regional staff, Monitoring & Evaluation team, and third-party consultants
- Assist in the organization of WaterCredit forums/stakeholder engagement forums and partners meetings in order to share knowledge and collaborate with stakeholders
- Provide input into and facilitate learning/dissemination of Water.org and partners' implementation experience and best practices
- Support capacity development activities pertaining to partner organizations and internally within Water.org.

Other key activities- Estimated time: 5%

- Serve as a knowledge base for Water.org, and represent Water.org at public events and in written publications to advance Water.org's mission
- Collaborate with the Development, Finance, Marketing, and Office of the CEO teams on projects as required.

Skills and Competencies

- **Program and Portfolio Management:** Skilled at managing a project lifecycle, overseeing the implementation of several related projects, mitigating risk, and handling multiple unrelated projects and activities at one time.

- **Sectoral Knowledge:** Sound and up-to-date knowledge of concepts, methodologies and techniques including demonstrated expertise in at least one specialty area within finance, WSS and/or international economic development. Clear understanding of issues related to gender and inequality in development and demonstrated commitment to promoting gender equality and pro-poor strategies within the organization and in program work. Innovative mind-set oriented toward constructive problem-solving, proactive strategic development and thought leadership. Familiarity with capacity building and technical assistance programs in the finance and WSS on sectors.
- **Networking:** Possesses strong contacts within local financial institutions (e.g. microfinance institutions, commercial banks, mobile network operators, cooperatives, etc.), relevant local governmental institutions, the local development sector, the WSS sector, and other relevant stakeholders. Demonstrated ability to identify new opportunities, establish cross-sector partnerships and design programs that are creative and leverage different stakeholders' capacities.
- **Communication:** Proficient in the use of effective communication techniques, particularly across a variety of constituencies and stakeholder groups. Skilled at cross-cultural communication and collaboration. Ability to communicate fluently and effectively in English, Spanish and Portuguese. Advanced knowledge of computer applications and ability to integrate technology into office and program activities.
- **Customer Focus:** Building strong customer relationships and delivering customer-centric solutions.
- **Nimble Learning:** Actively learning through experimentation when tackling new problems, using both successes and failures as learning fodder.
- **Drives Results:** Consistently achieving results, even under tough circumstances.
- **Collaborates:** Building partnerships and working collaboratively with others to meet shared objectives.
- **Self-development:** Actively seeking new ways to grow and be challenged using other formal and informal development channels.
- **Optimize Work Processes:** Knowing the most effective and efficient processes to get things done, with a focus on continuous improvement.
- **Manages Ambiguity:** Manages ambiguity by operating effectively, even when things are not certain or the way forward is not clear.
- **Instills Trust:** Gaining the confidence and trust of others through honesty, integrity, and authenticity.
- **Financial Stewardship:** Demonstrates fiscally responsible decision making as applicable to one's role

Qualifications and Skills

- Fluent Portuguese and Spanish language skills (reading, writing and speaking) required
- Experience working or living in Brazil required
- Master's degree in related field required. Additional relevant certifications, trainings and coursework also considered and preferred.

- A minimum of five years of relevant experience within the finance, WSS, and/or international economic development sectors with increasing levels of experience and responsibility.
- At least five years of project and program management experience required.
- Demonstrated proficiency in facilitation and capacity building to ensure collaboration and linkages between staff, donors, partners and stakeholders.
- Strong desire to contribute to increased access to water and sanitation
- Willingness to travel up to 30%
- Must have work authorization for the US.

Salary/Benefits

This position offers full-time benefits, including medical/dental insurance, life and disability insurance, retirement program and periodic review for merit and incentive pay based on organizational and personal achievement. Salary will be based on education and experience, and will coincide with similar nonprofit organizations in international development.
