Position Summary

The primary purpose of the Senior Researcher is to design, generate, and manage a wide variety of water and sanitation research and evaluation projects to assess program and business model effectiveness, and contribute to Water.org's evidence and knowledge base to support program implementation and scale. This is a collaborative and facilitative role that demands focus and cultural sensitivity, and requires a highly-resourceful individual with strong emotional intelligence, self-motivation, and analytical skills.

The Senior Researcher will work on the International Program (IP) team within its Monitoring, Evaluation and Learning (MEL) unit and work with other members of the Water.org team within the IP and Global Advocacy teams and across other departments, as well as with staff members based in the US and Water.org country offices.

Key Responsibilities

Research

- Lead in the development and implementation of Water.org's research strategy and manage associated project, work, and budget plans.
- Design, generate, and manage research projects, including longitudinal studies, operational and business model evaluations, outcomes/effectiveness analysis, and case studies.
- Manage and oversee research and evaluation consultants.
- Lead in the design of research methods and tools.
- Contribute to the development of Water.org's insights and evidence base for achieving impact through its interventions.
- Respond to in-house research queries.

Data analysis and dissemination

- Conduct research and analysis using qualitative and quantitative methods.
- Develop charts, figures, and analytical text for briefs and reports of research findings.
- Disseminate research findings to various stakeholders.



- Contribute to reports, research papers and learnings.
- Assist in devising methods and procedures for collecting, cleaning, organizing and processing data.

Requirements

- Master's degree in statistics, international development studies, economics or an appropriate related field.
- At least 6 years of designing and implementing research and/or conducting evaluations outside of graduate degree program.



- Strong knowledge of research and evaluation methods and approaches.
- Ability to analyze and synthesize information and draw conclusions and produce reports.
- Strong writing and analytical skills, including fluency in a statistical software package such as Excel, STATA, SPSS or R.
- Experience evaluating interventions, especially in development work.
- Must be authorized to work legally in the United States.

Travel Requirement

Must be willing to travel up to 5-10% of time domestically and internationally.

Salary/Benefits

This position offers full-time benefits, including medical/dental insurance, life and disability insurance, retirement program and periodic review for merit and incentive pay based on organizational and personal achievement. Salary will be based on education and experience, and will coincide with similar nonprofit organizations in international development.
